## **OBJECTIVES OF THE CONFERENCE**



The overall objectives of the conference will be to explore the roles and contributions that human rights instruments and institutions have in expanding, promoting, and protecting the spirit of human rights jurisprudence. The discourse of the conference will examine the efficacy and success of these instruments with a particular reference to marginalized sections of society, such as women, children, scheduled caste/scheduled tribes, etc. These objectives will be achieved through sharing experiences, lessons, and practices of human rights instruments and institutions from all regions and input from experts, activists, and civil society organizations.
